Information on Art. 13 of Legislative Decree of June 30, 2003, No. 196 Regarding the Privacy Act

Personal information provided shall be handled in print, digital and telematic form, by Ducati Motor Holding Ltd. Inc., located at via Cavalieri Ducati No 3, Bologna, Italy (hereinafter "Ducati"), and by its representative Sciacca Group Ltd. (hereinafter "Sciacca Group") located at via Mola Maggiorana No 4/6, Campagnano di Roma (Rome) Italy, and by the parties later designated by Ducati pursuant to Legislative Decree 196/2003, for the following purposes:

(i) To accept and process the application to participate in the Ducati Desmo Challenge 2011 ("DDC 2011"), and to execute the related acts and obligations, as well as provide anonymous information for statistical purposes. As such and exclusively for said purposes, this information may be communicated by Ducati to other corporations of Ducati Group, to companies with a shareholding in Ducati, to companies with contractual ties to Ducati or which form part of its distribution network, including as applicable those located in areas which are not part of the European Union, in which case the information shall be provided only for the purposes mentioned above. Said information will be revealed to its legal representative Sciacca Group and any parties that are later appointed by Ducati as its legal representatives and responsible for handling the information. Furthermore, events of the DDC 2011 shall be the subject of television broadcasts as well as the subject of photographic and news services including for promotional purposes, and therefore images and information of participants may be reproduced and broadcast for said purposes;

(ii) To perform market research, to investigate satisfaction levels, for promotional and commercial information activities. The information can be communicated by Ducati exclusively for these purposes to companies of the Ducati Group, companies with a shareholding in Ducati, companies with contractual ties to Ducati (which specialize in market research or in data preparation), or which form of its distribution network, as well as any in any areas which are not part of the European Union, in which case said information shall be handled exclusively for the purposes noted. The information can be revealed to the legal representatives and those responsible for handling same, appointed by Ducati and others for said purposes. Personal information shall not be broadcast for said purposes.

Providing the information requested for the purposes of point (i) above is strictly optional and not required by law; however it is necessary in order to complete the process for registering for the DDC 2011 and for completing the relevant requirements and obligations. Failure to provide the information requested will make it impossible to complete the registration procedure. Providing the information for purposes of point (ii) above is optional and not required by law; however failure to provide the information requested shall make it impossible for Ducati and its partners to contact applicant for the relevant activities indicated.

Legislative Decree June 30, 2003, No. 196 – Privacy Act. Art. 7 Right to access to personal information and other rights.

1. The interested party has the right to receive confirmation of the existence or lack of his personal information, even if not yet registered, and that said

information can be provided in intelligible form. 2. The interested party has the right to obtain the following information: a) the origin of the personal information; b) the purpose and form in which it is managed; c) the logic applied if the information is managed with the assistance of electronic instruments;

d) details identifying the owner, those responsible and the representatives appointed pursuant to Article 5 section 2; e) the subject and category where the personal information can be reported or which can be revealed to the representatives appointed by the State, the responsible parties or representatives 3. The interested party has the right to request: a) that the information be updated, corrected or, when requested, integrated with other information; b) that the information be cancelled, anonymously transformed or blocked from information handled in violation of the law, including

that which does not need to be preserved with regard to the purposes for which the information has been gathered or successively handled; c) proof that the operations noted in letters a) and b) have been revealed to him, including the content, the parties to whom the information was provided or broadcast,
